Minimum Eligibility Criteria (Teaching & Non-Teaching)

For PGT : Post Graduation in the concerned subject with at least 50% marks and B.Ed. Age Limit : Maximum 40 years as on 01.07.2025.

For TGT : Graduate / Post Graduate in the concerned subject with at least 50% Marks , B.Ed. & TET/CTET qualified.

For PRT : Graduate in the concerned subject with at least 50% Marks, B.Ed./D.El.Ed. & TET/CTET qualified.

For Nursery Teacher: Bachelors Degree with at least 50% marks and B.Ed./ D.El.Ed.

For Music/Dance:- Graduate in Music with at least 50% marks. For Librarian:- B.Lib./M.Lib. with at least 50% marks. For Painting/Art & Craft: BFA/MFA with at least 50% marks. For Physical Education: B.P.Ed./M.P.Ed. with at least 50% marks. For Computer Science: B.Sc.(Computer) / BCA with at least 50% marks & B.Ed. For LDC (Administration): Bachelors degree with at least 50% marks & Computer Proficiency in Typing & Computer (MS office). For LDC (Accounts)- Graduate (Commerce) with 50% marks, proficiency in typing and Computer (MS Office). For UDC: Graduate (Preferably Commerce) with 50% marks, proficiency in typing and computer (MS Office). For Graduate (Preferably Commerce) with 50% marks with knowledge of Drafting, Accounts, Rules & Regulation of Education Department (CBSE & State Govt.), proficiency in Computer, conversant in use of accounting software like Tally, etc. and 10 years administrative experience. For Nurse: Graduate with 50% marks with three years Diploma in Nursing & Registered Nurse & Midwife with Central or State Nursing Council (Full time). For Wellness Teacher: Graduate/Post Graduate in Psychology or Post Graduate in Child Development or Graduate/ Post Graduate with Diploma in Career Guidance and Counseling with 50% marks.

Age Limit : For all the posts except PGT Maximum 35 years as on 01.07.2025.

- Eligible candidates will be contacted by the school / Zonal office to apply for the DAV Computer-Based Test (DAV CBT-2025). Candidates must apply for 1 post only as CBT exam for multiple posts can fall on the same day.
- Those who qualify in CBT 2025 shall be issued a Provisional Eligibility Card, with which they can apply at any DAV School across the country. The final selection will be made on the basis of Demo & Panel Interview at school / Zonal Level.
- DAV –CBT will be conducted for all the posts collectively mentioned in this ad.
- However, different DAV Schools of the zone/state may have vacancies for different posts as per requirement.
