They are also requested to submit the enclosed proforma duly filled in accordance with the criteria already communicated along with the fee receipt for Rs.27,000/- towards the provisional fee in the school office on or before 05.01.2024. If any student/parent does not submit the counseling-cum-registration proforma, it will be assumed that he/she is not interested in continuing in the school and his/her claim for a seat in the school will be ceased.

Further, the SMC in its 199th meeting vide Resolution No-199(06) dated 09.03.2019 has been pleased to offer an exemption of school fees in Class XI to 3% of the total students of Class XI and in Class XII, subject to the condition that they secure minimum 90% in theory in Class XI Annual Examination.
