Rules for Verification of Marks

(i)

Verification of answer scripts means verification of the following:

- (b) Verification of addition of total marks.
- (c) Verification of correct transfer of marks to Title Page and Award List.
- (d) Verification of stitching of Additional Sheet(s) if any.

(No revaluation of Answer script/additional sheet shall be made as per the rules

- (ii) Application for verification of marks must be made within 10 days from the date of the declaration of result in the prescribed application form available in the school office.
- (iii) All such applications must be accompanied with D.D. of Rs. 100/- per subject towards the verification fee, to be drawn in favour of Regional Director, DAV Institutions, Odisha Zone-I, payable at Bhubaneswar.
- (iv) Photocopies of the answer scripts can be made available to the students on demand on payment of Rs. 500/- per subject through prescribed application form (available in school office), if he/she is not satisfied with verification of the addition/un-assessed portion/wrongly posting of marks in accordance to his/her application for verification.
- (v) Only those candidates who have applied for obtaining photocopy of the evaluated answer books can apply for re-evaluation of 10 questions (Only in theory paper) of his/her choice on payment of Rs.50/- per question per subject through prescribed application form available in school office.
- (vi) If the mark of any student is changed after verification, the amount deposited shall be refunded.
- (vii) If any error in evaluation is found at the end of the system, the amount deposited for the purpose will be refunded on application.
- (viii) In no case the verification of Marks shall be done in the presence of the candidate or anyone else on his/her behalf, nor will the answer books be shown to him/her or his/her representative.
- (ix) The marks on verification will be revised upward or downward, as per the actual marks obtained by the candidate in his/her answer book.
- (x) The communication regarding the revision of the marks if any, shall be sent to the candidate through concerned school.
- (xi) The Regional Directorate will not be held responsible for any loss or damage or any inconvenience caused to the candidate, consequent on the revision of marks or delay in communications for reasons beyond control.
- (xii) The Regional Directorate shall revise the Marks Statement in respect of such candidates even if the previous marks statement is not returned by the candidate.
