The bidders are also required to enclose a D.D. of Rs.50,000/- drawn in favour of "Principal, DAV Public School, Chandrasekharpur" payable Bhubaneswar along with the Quotation Form towards the earnest money. The bidders are also required to submit photocopy of the PAN card along with the quotation. The earnest money of the unsuccessful bidders will be refunded within seven working days without any interest. The successful bidder shall be issued the work order with the terms and conditions as mentioned in instructions for the timely completion of the works which shall be treated as an agreement between the school authority and the contractor.

The envelope containing the quotation must be closed and marked "execution of internal sewerage pipe lines and connection to the manhole/chamber of WATCO (Phase-II) in D.A.V. Public School, Chandrasekharpur" on the top of the envelope. The quotations received after the stipulated date and time shall not be considered.

The quotations will be opened on 09.02.2024 at 4.00 P.M. The bidders may remain present physically or by authorized representative during opening of the quotations.

#### Instructions to the Bidders:

- 1. The Bidders are free to visit the site with permission from the school authority.
- 2. The details of works to be executed as per the quotation form.
- 3. The rates shall be inclusive of all materials, excavations, labour charges, transportation charges, civil works, cleaning of debris from the premises, all admissible taxes, etc. complete in all respects.
- 4. The bidders must have valid PAN, GSTIN, GST numbers.
- The execution of works should be commenced within 10 days from the date of receipt of the work order.
- 6. During execution of the works heavy machines should not enter into the playground.
- 7. Adequate precautionary measures should be taken by the contractor during the school hours for safety and security of the students.
- 8. The time limit for completion of the work is one month from the date of issue of the work order.
- 9. Payment will be made after completion of the works subject to the satisfaction of the undersigned as well as the works committee.
- 10. TDS admissible under rules shall be deducted from the bill.
- Earnest money of the successful bidder shall be refunded at the time of settlement of the bill on completion of the work on due verification of the works committee.
- 12. 5% of the bill shall be kept as security money which will be paid without any interest after completion of six months on observation of the quality of the works by the works committee.
- 13. The lowest quoted price after approval of the competent authority shall be continued till completion of the works. No revision of the rate shall be entertained on the plea of increase of market price or for any reason whatsoever.
- 14. Problems, if any, during the execution of work must be communicated to the school authority in writing.
