The bidders are also required to submit photocopy of the PAN card along with the quotation. The earnest money of the unsuccessful bidders will be refunded within seven working days without any interest. The successful bidder shall be issued the work order with the terms and conditions as mentioned in instructions for the timely completion of the works which shall be treated as an agreement between the school authority and the contractor.

The envelope containing the quotation must be closed and marked "execution of internal sewerage pipe lines and connection to the manhole/chamber of Watco in D.A.V. Public School, Chandrasekharpur" on the top of the envelope. The quotations received after the stipulated date and time shall not be considered.

The quotations will be opened on 07.11.2023 at 4.00 P.M. The bidders may remain present physically or by authorized representative during opening of the quotations.

- The rates shall be inclusive of all materials, excavations, labour charges, transportation charges, civil works, cleaning of debris from the premises, all admissible taxes, etc. complete in all respects.
- 4. The bidders must have valid PAN, GSTIN, GST numbers.
- 5. The execution of works should be commenced within 10 days from the date of receipt of the work order.
- During execution of the works heavy machines should not enter into the playground.
- 7. Adequate precautionary measures should be taken by the contractor during the school hours for safety and security of the students.
- 8. The time limit for completion of the work is one month from the date of issue of the work order.
- 9. Payment will be made after completion of the works subject to the satisfaction of the undersigned as well as the works committee.
